Activity Agreements – Staff Report for January 2025

This memorandum serves as the Staff Report for January 2025 regarding specified¹ Water Authority activities not separately addressed on the Board meeting agenda.

1. Integrated Regional Water Management (IRWM) Activity Summary

General Westside-San Joaquin Integrated Regional Water Management Plan (IRWMP)

Self-Help Enterprises is revising a draft Community Water Needs Assessment for disadvantaged communities (DACs) in the Westside San Joaquin IRWM Region, incorporating revisions from staff. The Assessment is being updated to identify and prioritize the most critical drinking water needs for DACs in the region, especially during drought years. The revised draft will be distributed to an IRWM Activity Agreement Member subcommittee for review and input prior to completion, which is anticipated in February.

2. Sustainable Groundwater Management Activity (SGMA) Activity Summary

General SGMA Activities

Groundwater Sustainability Agencies (GSAs) in the Delta-Mendota Subbasin are finalizing the Pumping Reduction Plans (PRPs) for their respective Zones. The PRPs are part of the adopted GSP for the Subbasin. They are specific to identified "zones" and are a key component to effective local SGMA implementation. The PRPs will guide GSAs as they seek to avoid "undesirable results" as defined in the law for six sustainability indicators. These indicators include groundwater levels, subsidence, water quality, loss of storage, and interconnected surface water. PRPs will be implemented starting in January 2025.

¹ For the sake of completeness, this includes those Activity Agreements that have been approved by the Board of Directors, but not yet signed by all interested members and/or participants (i.e., the Los Vaqueros Expansion Project Activity Agreement, the Exchange Contractors 2019-2023 Transfer Program Activity Agreement, and the Westside-San Joaquin Integrated Regional Water Management Activity Agreement).

Additionally, the retirement of the Water Authority's Water Resources Programs Manager has resulted in the need to address future program management for SGMA implementation in the D-M Subbasin. Staff is preparing a Request for Proposal for Program Management Services for Implementing the Final Delta-Mendota Subbasin Groundwater Sustainability Plan.

Coordinated Activities

Some Coordination Committee members and technical consultants are meeting with State Water Resources Control Board (SWRCB) staff as the Subbasin seeks to avoid a possible "Probation" designation. SWRCB Staff continues to request additional details on the GSP's proposed actions on the water quality sustainability indicators.

Outreach efforts were placed on a temporary hold while the California Department of Water Resources (DWR) finalizes a Facilitation Support Services (FSS) grant agreement for the Subbasin. Previous FSS grants were a vital part of local education and outreach efforts during the GSP development process. Proposed FSS activities in the pending agreement include language translation and meeting facilitation. Much of the new outreach will focus on the PRPs. GSAs also seek to renew coordination efforts with neighboring subbasins, especially on subsidence challenges. FSS grants are provided by DWR at no cost to the GSAs.

3. Drainage Activity Summary

Grassland Basin Drainage Management Steering Committee Activity Summary

The Grassland Bypass Channel gates have remained closed since February of 2024. Selenium concentrations in Mud Slough and the San Joaquin River remain below the water quality objective.

GBP Activities

- General administration: Review and approve consultant billing. Field review of drainage conditions and correspondence with SJRIP manager. Correspondence with Regional Board staff. In compliance with the 2019 Order, The Regional Board will hold a Stakeholder Meeting on February 5th (via TEAMS). The link for this meeting can be obtained from Ashley Peters at the Regional Board (ashley.peters@waterboards.ca.gov).
- Mud Slough Restoration Project: The intent of this project is to restore Mud Slough in accordance with the 2010 MOU between the Authority and California Department of Fish and Wildlife (CDFW). The Water Authority adopted the CEQA for the project in December 2021, which was not challenged. CDFW provided a letter in January 2024 that accepted the Water Authority's proposed actions to restore Mud Slough as it relates to the MOU, and implement of those activities is tentatively scheduled for the spring/summer of 2025. There is an issue separate from the MOU concerning restoring Mud Slough flows into Newman Lake. Alternatives to address that are still in discussion.
- Compliance Monitoring: Monitoring in compliance with the 2019 revised WDRs and 2019 Use Agreement is a continuous and daily effort. Regular flow, water quality and toxicity monitoring are required at eight locations at a frequency that varies from monthly to daily. The annual stakeholder presentation, hosted by Regional Board staff, will be held



- online in February. This will provide a public summary of the operations of the Grassland Bypass Project and monitoring results for the 2024 monitoring year.
- <u>Grassland Drainage Area Coalition:</u> Work continues to provide coverage for farmers within the Grassland Drainage Area for the Irrigated Lands Regulatory Program.
- <u>Proposition 84 Grant:</u> Work is ongoing to support the Prop 84 Grant administered by Panoche Drainage District for improvements to the San Joaquin River Improvement Project. The Short-Term Storage Basins construction is nearing completion. Other projects are in design phase.

San Joaquin Valley Drainage Authority Activity Summary

- Participate in conference calls with the Regional Board to respond to questions on surface water quality management plans and required follow up. Working with the Regional Board to formulate a more efficient focused outreach program to address sediment and surface water quality impacts to receiving waters. Direct consultants on various issues to meet General Order requirements.
- Westside San Joaquin River Watershed Coalition: Work continues to provide coverage under the Irrigated Lands Regulatory Program for farmers within the Westside San Joaquin River Watershed Coalition. The work includes managing the monitoring program, assisting farmers with the necessary reporting to comply with the program and preparing reports for the Regional Board. Analyze pyrethroid Focused Outreach data for follow up MPIRs. Respond to Regional Board's comments of recent Surface Water Focused Outreach and schedule meetings to discuss future efforts.
- Groundwater Protection Formula, Values and Targets: Coalitions have developed a
 methodology to establish nitrogen loading Values and Targets as required by the WDRs.
 Collaborating with other Coalitions to provide written comments to a set of questions
 proposed by the SWRCB that an Expert Panel will be tasked to answer concerning nitrate
 targets.
- Management Practices Effectiveness Program: Attend conference call meetings of the MPEP group. Developing work schedules to implement nitrogen control measures for farmer member compliance. Crop-Specific Acceptable Ranges report was presented to Regional Board in October 2024 and the Coalition is awaiting their approval.
- <u>Central Valley Groundwater Monitoring Collaborative:</u> Attend conference call meetings
 to give direction to program. Finalize work on "N" removed coefficients for minor crops
 grown in the central valley. Work with other coalitions and staff to coordinate and
 collaborate with SGMA efforts regarding groundwater quality monitoring and reporting.
- Management Zones: Attend meetings with other Management Zone dischargers to form an Advisory Committee that will approve Management Zone activities. Negotiated with other discharge groups and established a schedule of equitable percentages of cost share. Attend Central Valley Salinity Coalition meetings to inform SJVDA regarding Management Zone formation. Along with other dischargers, submitted the required PMZIP and EAP reports in a timely manner.
- <u>Salt Control Program:</u> Collaborated with District Managers to provide a final assessment
 of the Phase I Archetype model of the Delta Mendota subwatershed. This work is being
 supported through the SJVDA budget. Collaborate with the P&O Study group to finalize

District provided data used for modeling. This work is being supported through the SJVDA budget.

 Prop 84 Real Time Program Grant: Work on this grant project is complete and the final grant report in progress. The grant agreement ended in December 2024 and the final invoicing will be submitted by the end of March 2025.

7. Regional Water Quality Management Activity

A. Westside Watershed Coalition Update

1) Update Crop-Year 2023 Reporting Deadlines

Watershed Coordinator Orvil McKinnis discussed the Regional Board's procedure to compel growers to send in their late INMPSR forms and he noted that when the process moves into Administrative Action, the Coalition has no control over the outcome. McKinnis reported that the AMPINAR, its related data and attachments had been submitted to the Regional Board in a timely manner.

2) Management Practice Evaluation Program Status

Watershed Coordinator Orvil McKinnis reported that he continues to attend joint MPEP meetings and that the group was working on a list of "N" removed crop coefficients for minor crops in the Central Valley. McKinnis mentioned that the MPEP group was preparing individual Coalition costs for the next fiscal year.

3) Review Monitoring/Reporting Status

Watershed Coordinator Orvil McKinnis reported on the pyrethroid and surface water toxicity exceedances that occurred during monitoring events 207 & 208. McKinnis briefly discussed the monitoring sites where exceedances for pyrethroids occurred.

4) Management Plan Updates and Outreach Activities

Watershed Coordinator Orvil McKinnis mentioned that focused outreach meetings had been scheduled for early November 2024. Consultant Zach Griffen reported on recent "tailgate" meetings with growers on the Westley Wasteway watershed and that the meetings were conducted to discuss recent pyrethroid exceedances in the watershed. Griffen mentioned that written reports for each of the meetings were drafted and sent to the Coalition for their review and acceptance. Director Chase Hurley suggested a 6-month follow-up after the initial meetings might provide improved water quality benefits. The Watershed Coordinator took the suggestion under advisement.

5) Groundwater Protection Values

Watershed Coordinator Orvil McKinnis reported that the State Water Resources Control Board continues to organize an Expert Panel to address impacts of nitrate to groundwater. Consultant David Cory mentioned that the questions that the Panel needed to answer have been released for public comment. Cory stated that the Panel's conclusions could negatively impact the work that the Coalitions have done on Groundwater Protection Values as well as the General Order.

8. Update on Grant Programs

A. Update of Salt and Boron TMDL Real Time Management Program

Watershed Coordinator Orvil McKinnis reported that work continues on maintaining the stations, gathering monitoring data, and computer modeling to determine and manage salt discharges to the San Joaquin River. McKinnis stated that the Grant will



end 12/31/2024.

9. Report on CV-SALTS

A. Nitrate Management Zone

Consultant David Cory presented a program cost allocation summary and mentioned that the Ag allocation portion would be equitably split between the Westside and Grassland Coalitions. Cory reported that the allocation percentages were still under industry sector consideration and had not yet been finalized. Cory stated that given Ag's larger cost allocation it should have veto power on the Management Zone Advisory Committee. There was a general discussion that the fee allocations between Ag and Dairy should be based on nitrate loading.

B. Prioritization & Optimization (P&O) Study

Consultant David Cory mentioned that work on the Study is progressing. He reported that meetings were being scheduled with Water and Irrigation Districts seeking their input on the modeling progress to date.

Delgado highlighted the particular changes that would take place, including the change of the Executive Directors position from the Water Authority to the Drainage Authority. There was a general discussion of the accounting procedure to process invoices and prepare checks for payment.

6. Regional Water Quality Management Activity

A. Westside Watershed Coalition Update

 Status of 2023 Reporting Deadlines: Update on RWQCB Notices to Growers

Watershed Coordinator Orvil McKinnis discussed the Regional Board's procedure to compel growers to send in their late INMPSR forms and he noted that when the process moves into Administrative Action, the Coalition has no control over the outcome. McKinnis reported that the Regional Board had recently sent delinquent growers a Notice of Violation and that the grower has 15 days to respond to the notice.

2) Management Practice Evaluation Program Status

Watershed Coordinator Orvil McKinnis reported that he continues to attend joint MPEP meetings and that the group has submitted to the Regional Board a list of "N" removed crop coefficients for minor crops in the Central Valley.

3) Review Monitoring/Reporting Status

Watershed Coordinator Orvil McKinnis reported on the pyrethroid and surface water toxicity exceedances that occurred during monitoring events 209 & 210. McKinnis briefly mentioned that he has had recent meetings with the Regional Board over these exceedances and that they are adamant that the Coalition needs to something more to curtail the exceedances. He stated that the meeting scheduled for the end of the month would include the Regional Board's Assistant Executive Officer.

4) Management Plan Updates and Outreach Activities

Watershed Coordinator Orvil McKinnis mentioned that focused outreach meetings for pyrethroid exceedances had been conducted November and December 2024 in Los Banos. McKinnis reported that roughly a third of those required to attend showed up. He stated that a video was being produce and would be posted on-line to facilitate the non-attendees' requirement to attend the meeting.

5) Groundwater Protection Values

Watershed Coordinator Orvil McKinnis reported that the State Water Resources Control Board continues the Expert Panel process to address impacts of nitrate to groundwater. Consultant David Cory reported that the Expert Panel will have wide latitude to review Ground Water Protection Values and other nitrate related issues. Cory mentioned that the SRWCB had released a Bioassessment and Biointegrity report and that the report's conclusions could have negative impacts to growers. He stated that the Coalitions were working with attorney Tess Dunham to provide written comments to the SWRCB regarding the report.

7. Update on Grant Programs

A. Update of Salt and Boron TMDL Real Time Management Program Watershed Coordinator Orvil McKinnis reported that the Grant ended on 12/31/2024 and that the Consulting Team was finalizing data input and generating a final report.

8. Report on CV-SALTS

A. Nitrate Management Zone

Consultant David Cory reported that an Advisory Committee had been formed and that AG controlled 6 of 12 total seats and that it represents veto authority in the committee. Cory mentioned that the fee structure between the different discharge industries had been set and that AG was committed to 65 percent of the Management Zone annual budget. He mentioned that the Pre-Implementation and Early Action Plan reports had been timely submitted.

B. Prioritization & Optimization (P&O) Study

Consultant David Cory mentioned that work on the Archetype has been completed and that during the process several meetings were held with water and irrigation districts. Cory briefly discussed the surface and ground water scenarios that resulted through the study and that a second Archetype is being planned. There was a discussion on the need to get the smaller water and irrigation districts involved in the study.

FUND DESCRIPTIONS

San Joaquin Valley Drainage Authority General Membership (Fund 900)

The San Joaquin Valley Drainage Joint Powers Authority (Drainage Authority) was formed on January 1, 1999. The Drainage Authority was formed to provide a forum for public agencies to participate in coordinated drainage activities, such as the need to have a master drainage plan to address salt balance for irrigated agricultural lands within the San Joaquin Valley. This is the General Fund for the San Joaquin Valley Drainage Authority for general membership.

Each of the members in the Drainage Authority is a public entity empowered to provide water service to lands within their boundaries, provide drainage service, coordinate the operation and maintenance of works and facilities, and provide for the distribution and use of water for irrigation and drainage.

Administration

The Drainage Authority has contracted with the San Luis & Delta-Mendota Water Authority (Water Authority) to provide the administrative functions of the Drainage Authority. The administrative cost of the Drainage Authority is reimbursable to the Water Authority on a monthly basis.

Accounting and Audit

The San Joaquin Valley Drainage Authority has been set up as a separate accounting entity and will be audited separately as a distinct entity.

Irrigated Lands Regulatory Program (Fund 901)

This is a special revenue fund managed by the Regional Water Quality Management Activity. The Drainage Authority is serving as the umbrella agency to allow formation of a regional watershed coalition for purposes of the Irrigated Lands Regulatory Program (formerly, the "Conditional Ag Waiver Program") issued by the Regional Board. Funding for this project will come from participating members and watershed coalition participants who have executed Memoranda of Understanding in order to participate under the umbrella of the watershed coalition.

SUBJECT: Comments on A Technical Foundation for Biointegrity and Eutrophication Indicators and Thresholds for Modified Channels, Intermittent Streams and Streams on the Central Valley Floor

Dear Ms. Cooke:

The above listed Central Valley Irrigated Agricultural Coalitions (Ag Coalitions) appreciate the opportunity to review and submit comments on the report titled *A Technical Foundation for Biointegrity and Eutrophication Indicators and Thresholds for Modified Channels, Intermittent Streams and Streams on the Central Valley Floor* (Report), which was prepared by the Southern California Coastal Water Research Project (SCCWRP) through a contract with the Central Valley Regional Water Quality Control Board (Central Valley Water Board) and the State Water Resources Control Board (State Water Board). We also appreciate that the Central Valley Water Board sought to have a study conducted due to significant gaps in technical analysis of stream condition and eutrophication indicators in modified channels and to develop an understanding of the potential limits to biological integrity and tools as they apply to modified channels in the Central Valley. At this time, however, we find certain findings and conclusions in the Report troubling based on our review of the Report, and more importantly, based on our combined years of experience with surface waters throughout



the entirety of the Central Valley Region. Accordingly, we request that the State Water Board and the Central Valley Water Board avoid using reference-based thresholds to evaluate and determine if there is biological degradation to aquatic life in the thousands of Central Valley streams and channels. Our combined comments are provided herein.

Part 1 - General Comments

As a preliminary matter, we must first express our significant concerns with the process undertaken for the development of this Report. Collectively, the 13 Ag Coalitions on this letter spend millions of dollars each year monitoring Central Valley surface waters from as far north as Shasta County to Kern County in the south. Such efforts under the irrigated lands program have been happening for over 20 years. As a result, the Ag Coalitions and their respective consultants have expansive and in-depth knowledge regarding water quality conditions throughout the entirety of the Central Valley. Yet, despite having this vast knowledge base, the Ag Coalitions were not consulted by SCCWRP during the preparation of the Report or asked to review a draft of the Report.

Moreover, the Report includes in its acknowledgments section a statement suggesting that participants from the "San Joaquin Irrigated Lands Task Force" provided guidance and technical advice on several aspects of the study. To the knowledge of the 13 Ag Coalitions commenting here, no such "San Joaquin Irrigated Lands Task Force" exists. If one does exist, it is unrelated to the Irrigated Lands Programs administered by the Ag Coalitions. To our recollection, there may have been one initial video conference several years ago when this project was first kicked off with SCCWRP staff whereby representatives from some of the Ag Coalitions were invited to attend. However, other than that one initial discussion, no further efforts were made to discuss this project, its results, findings, conclusions or the Report with the Ag Coalitions.

Considering the potential implications and ramifications that a Report such as this can have on Central Valley agriculture, we would expect there to be far more effort to engage the Ag Coalitions throughout the entirety of this project and gain insight from those that have been actively monitoring surface waters throughout the Valley for more than 20 years. Moving forward, we look to work more closely with the Central Valley Water Board, State Water Board, and others conducting studies of this significance and magnitude.



Part 2 - Comments on Sections of the Report¹

• In Part 1a Conclusions, the Report makes a statement that there is "sufficient evidence that reference-like scores are attainable within the Central Valley." Based on our review of the Report as well as our practical knowledge of the Central Valley, we fail to see sufficient evidence for making such a statement. For example, the Report identifies two sites on Deer Creek in Tehama County as having high CSCI scores. Both of these sites, as noted in the Report, are basically at the boundary of the Sierra Nevada ecoregion and do not represent what may or may not be attainable in the Central Valley. Similarly, for less disturbed sites, the Report calls out three sources of sites, of which many are located outside of the Central Valley ecoregion.

Moreover, irrigation and drainage canals in the Central Valley, which are located in agricultural settings, were not designed to support thriving ecosystems nor are they operated and maintained in such a manner. To the contrary, these canals were designed and are maintained to prevent flow restrictions on the movement of irrigation and drainage water. Specifically, the goal of such conveyance channels is to reduce or eliminate water loss and provide rapid delivery of water to fields, which is incompatible with creating and maintaining habitat for aquatic organisms. In short, such channels are operated and maintained in a manner that prevents the presence of vegetative matter or removes such matter when it becomes present. To suggest that such channels may achieve reference-like scores based on the limited reference and less disturbed sites discussed in the Report, which do not represent or reflect typical Central Valley channels, does not appear to be sufficient evidence in our opinion.

With respect to statements regarding use of alternative thresholds based on "best attainable" or "best observed," we find that this recommendation is premature without further discussion and technical analysis prior to suggesting that such an approach is appropriate. We recommend that the Central Valley Water Board and the State Water Board refrain from establishing alternative thresholds as recommended by the Report until more information and data is available for Central Valley surface waters — including modified channels designed for specific agricultural purposes.

 In Part 1b, page 45, the Report looks to answer the question "Do indices work in intermittent streams in arid portions of California?" However, upon review of the information that follows, the Report does not appear to answer this question, at least as it applies to the arid Central Valley. All of the data and information

¹ Notably, the comments provided here are not intended to be in-depth comments on highly technical components of the Report. To provide such in-depth comments, the Ag Coalitions would need to engage specialized consultants to review the data relied on by the Report authors, and the analysis within. Considering that there was a limited 30-day comment period, it was not possible to conduct such a thorough analysis.



reviewed in this section of the Report is outside of the Central Valley, and thus not applicable.

In Part 1b Conclusions and recommendations, the Report suggests alternative
approaches to interpret CSCI scores in regularly flowing intermittent streams in
Northern California. We find this statement confusing as it is unclear if the Report
authors include the Central Valley when they reference Northern California.
Considering that there is a lack of reference sites within the Central Valley, we fail
to see how this statement could apply to the Central Valley.

Further, at the bottom of page 64, the Report concludes that declines in scores could be used to assess the effectiveness of antidegradation programs. Such a conclusion is inappropriate as it fails to explain what the Report considers to be an "antidegradation program." Antidegradation is a state and federal policy that applies to permitting decisions of the State and regional water quality control boards to protect high quality waters and is traditionally applied on a pollutant-by-pollutant basis. It is not a "program" onto itself and reference in the context of this Report is inappropriate.

On page 65, the Report recommends the use of ASCI scores in both Southern and Northern California. Similar to our comment above, we are uncertain as to the Report's definition of Northern California. If the statement is intended to apply to the Central Valley, we find it inappropriate due to the lack of data and information available for application of such indices to the Central Valley.

 In Part 1 Summary Recommendations and conclusions section, on page 66, the Report concludes that the CSCI and ASCI may be used to assess biological integrity in perennial streams in the Central Valley and Modoc Plateau ecoregions. However, the data and information presented throughout the Report does not support this conclusion considering the significant difference between Central Valley waterbodies and the reference sites used to calibrate the CSCI and ASCI.

Further, we recommend that the Central Valley Water Board and State Water Board refrain from using the CSCI and ASCI to develop alternative thresholds in the Central Valley until further study is conducted to determine if their use is appropriate. As stated repeatedly in the Report, there are no reference sites within the Central Valley ecoregion and the "less disturbed sites" are not reflective of water bodies and channels on the Central Valley floor. As a result, there is no evidence available to suggest that use of the CSCI and ASCI for developing alternative thresholds is appropriate. Moreover, before the State Water Board or Central Valley Water Board look to use CSCI or ASCI for regulatory determinations, such use must be subject to the State and regional boards policy making processes, which include notice and public comment.

- In Part 2, page 68, the Report provides a definition of what constitutes a modified channel. It then provides a caveat that the definition of modified channel in the Report is not intended to reflect or supersede definitions of jurisdictional waterbodies. We appreciate that the Report is not attempting to define what may be considered a water of the United States, or a water of the state, for regulatory purposes. However, this statement should be much clearer and specifically note that the definition of modified channel in the Report is unrelated to definitions of what may be a water of the United States, or a water of the state. Such determinations are outside the scope of this Report. Ultimately, application of biological integrity scores to any water of the United States or water of the state is a policy question left for the Water Boards.
- In Part 2 generally, the Report does not consider that many modified channels in the Central Valley serve a specific purpose with respect to the movement of water for irrigation or drainage of agricultural lands. As noted above, due to their specific purpose, such channels are operated and maintained in a manner to remove barriers to flows (e.g., vegetative matter) and to prevent flooding of such channels during winter storms. This means that modified channels of all types, including soft bottom channels, are cleaned periodically and vegetation is purposefully removed to maintain function of the channel. Whether such channels can attain high CSCI or ASCI scores must consider these types of standard operational and maintenance activities, which the Report does not discuss or consider. Instead, the Report looks only to classify a modified channel based on its characteristics and ignores a channel's essential function and operations associated with the channel. Considering the necessary operation and maintenance activities associated with many of the Central Valley's modified channels, such activities need to be considered by the Central Valley Water Board and the State Water Board before deciding that the use of the CSCI and ASCI is appropriate for such channels - even if alternative thresholds are developed.
- In Part 3, page 105, the Report states that alternative thresholds are not appropriate for soft bottom channels with one hardened side because high scores are attainable. Similar to the comment above, we question this conclusion considering that it does not consider that these channels may serve a specific purpose or function and thus have regular maintenance activities that greatly impact the ability of a channel to reach a high CSCI or ASCI score.
- On page 107, the Report makes the comment that determining long-term constraints is a political decision that should reflect community values and agency priorities. We find this statement inappropriate as it indirectly implies what should drive determinations of long-term constraints in a water body. Rather than making this statement, we suggest that the sentence merely state that this is a policy decision outside the scope of the Report.



- In Part 3 Conclusions, page 145, the Report concludes that alternative CSCI thresholds could be useful for Central Valley Floor streams but yet at the same time admits that there is not sufficient evidence to support such a statement. Considering the lack of evidence to support the conclusion, the Central Valley Water Board and State Water Board should disregard the Report's conclusion as it applies to Central Valley Floor channels/streams. Meaning that the Report's value, including the best-observed thresholds in Table 22, are not appropriate for application to the Central Valley Floor streams or channels.
- In Part 3, Conclusions, page 146, the Report appears to cross over into the realm
 of policy by stating that best observed biointegrity thresholds are more helpful for
 prioritization and setting interim goals. This statement is a judgment call on how
 the State Water Board and/or regional water boards should use best-observed
 biointegrity thresholds and should be disregarded.

Overall, we find that the Report lacks sufficient evidence to support the use of biointegrity and eutrophication indicators for "streams" on the Central Valley Floor. Based on our collective years of experience and knowledge, it lacks a fundamental understanding of Central Valley Floor channels that were constructed or modified for specific agricultural purposes and specifically maintained to allow the channels to perform their primary functions. Rather, it appears to categorize and assess modified channels based on their physical characteristics without regard to their function and maintenance and operations. By ignoring such key factors, the Report leads readers to believe that bointegrity and eutrophication indicators may be appropriate to assess biological health in these streams. We are not convinced by the information presented in the Report that there is evidence to support such conclusions.

In conclusion, we recommend that the State Water Board and Central Valley Water Board refrain from using such indicators in the Central Valley to make regulatory or policy decisions. This is especially relevant with respect to determinations of impairment for 303(d) lists based on degradation to biological communities and extends to any other determination or interpretation of narrative water quality objectives for the protection of aquatic life beneficial uses.

Ric Ortega/Grassland Water District made the motion to approve the consent calendar. Vince Lucchesi/Patterson Irrigation District seconded the motion, which was approved unanimously by those present.

Action Items

6. Committee to Consider Staff Recommendation to Adopt the 2025 Regular Meeting Calendar for the Delta-Mendota Subbasin Coordination Committee, Wiersma/Brodie

John Brodie referred Committee members to a staff memo in the Board packet with dates and meeting locations, noting that some dates had to be changed from the normal second Monday and a few dates needed an alternate location including February. Ric Ortega offered the Boardroom at Grassland Water District for the February meeting. Vince Lucchesi made the motion to Adopt the 2025 Regular Meeting Calendar. Joe Hopkins seconded the motion, which was approved unanimously by those present.

7. Committee to Consider Ratification of SLDMWA Approval of the FY 2026 Coordinated Delta-Mendota SGMA Budget, Hopkins/Ramirez/Petersen

John Brodie referred Committee members to a staff memo within the meeting materials. SLDMWA Accounting Staff members are working on a reconciliation of costs and billing, which will be presented at a future Coordination Committee meeting. Ric Ortega made a motion to ratify SLDMWA approval of the FY 2026 budget with the condition that FY 2026 invoices be withheld by SLDMWA until the Committee is able to review the account reconciliation. Vince Lucchesi provided the second and the motion was passed unanimously by those present.

8. Committee to Consider Leadership Rotation for the 2025 Year, Brodie/Layne

Lauren Layne noted the leadership rotation schedule as described in the Committee's Memorandum of Agreement, which is done alphabetically. The Committee could choose to leave leadership as is, but that would require those in-line for chair and vice-chair roles to waive their duties. 12. Annual Report Update, Dumas

Leslie urged GSAs to upload their water use data to the DMS as soon as possible. Woodard & Curran is working to reformat the annual report for the single GSP.

13. Public Agency Updates, Layne

Lauren Layne referred Committee Members to a memo in the meeting packet regarding new state laws and regulations that are specific to GSAs and GSA Board Members.

She also told Committee members she is aware that DWR is planning to hold a public meeting on its release of a subsidence BMP document in Los Banos.

Chase Hurley reported Stanislaus and Merced Counties are looking to use their sole source policies to pay for monitoring well construction for the wells within their jurisdiction.

2) Construction Status, Francis

Construction could proceed on the well in Patterson Irrigation District while awaiting sole source decisions from the counties.

c) Status and Deadlines for Completion of Other Components, Dumas

Leslie said all work should be completed so invoices can be submitted no later than April of 2026 to DWR for review and approval.

d) Status of Grant Administration Budget, Dumas

Vince Lucchesi/PID called the meeting to order at 1:29 PM.

 Committee to Consider Corrections or Additions to the Agenda of Items, as authorized by Government Code Section 54950 et seq.

There were no corrections or additions to the agenda of items.

Opportunity for Public Comment

No public comment was provided.

- 4. Committee to Review and Take Action on Consent Calendar, Lucchesi
 - Minutes for the November 27, 2024 Special Meeting of the Northern Delta-Mendota Region Management Committee
 - b. Budget-to-Actual Report

Maria Encinas/City of Patterson provided the motion to approve the Consent Calendar and Anthea Hansen/DPWD seconded. The motion was passed unanimously by those present.



5. Committee to Consider Staff Recommendation to Adopt the 2025 Regular Meeting Calendar for the Northern Delta-Mendota Management Committee, Petersen/Lucchesi

The proposed date for the Committee meeting in December 2025 was revised to Wednesday December 10, 2025. Subject to this revision, Maria Encinas provided the motion to approve the 2025 Regular Meeting Calendar and Anthea Hansen seconded. The motion was passed unanimously by those present.

6. Committee to Consider Approval of the Draft FY 2026 Northern Delta-Mendota Region Budget (Fund 64), Petersen

Scott Petersen/SLDMWA described revisions to the draft FY2026 budget made after it was previously presented to the Committee. The SLDMWA Board is scheduled to adopt the budgets at its meeting on January 9, 2025.

Anthea Hansen provided the motion to approve the draft FY2026 budget for the Northern Delta-Mendota region, and Maria Encinas seconded. The motion was passed unanimously by those present.

7. Committee to Consider Staff Recommendation to Revise Exhibit "C" of the Second Amendment to the Northern Delta-Mendota Region Activity Agreement, Petersen

Scott Petersen explained the rationale for revision of the current cost allocation formula, noting that it will be simpler to administer, but will result in small changes in the cost allocation percentages between the participating agencies.

Maria Encinas provided the motion to approve the revision to Exhibit C, and Anthea Hansen seconded. The motion was passed unanimously by those present. Committee members requested that staff develop a letter agreement to formalize the Exhibit "C" revision.

8. Committee to Consider Authorizing its Representative to the Coordination Committee to Approve the Draft FY2026 Coordinated Budget (Fund 63), Petersen/Pierce

Scott Petersen explained that, as requested, the draft FY2026 coordinated budget was revised to include an additional \$100K to fund the first year of the Domestic Well Mitigation Fund. Due to contracting issues, the planned expenditures for installation of the interconnected surface water monitoring wells were also extended from FY2025 to FY2026.

The Committee discussed the status of the FY2025 budget and invoicing. There may be outstanding invoices that SLDWMA needs to transmit to the member agencies. There are multiple complexities in the allocation of expenses that exacerbate this process. Anthea Hansen requested near-term clarification from SLDMWA regarding the FY2025 budget status, and whether a credit will be issued.

Anthea Hansen provided the motion to authorize its representative to the Coordination Committee to approve the draft FY2026 Coordinated Budget and Maria Encinas seconded. The motion was passed unanimously by those present.

9. Report of the Representative to the Coordination Committee, Lucchesi/Petersen

Scott Petersen reported that topics addressed during the December 2024 Coordination Committee meeting included the proposed draft FY2026 budget, the need for program management services, and addition of \$100K to the FY 2026 budget to initiate funding of the well mitigation program. The meeting also included a report regarding technical engagement with the



SWRCB staff and status reports from individual Subbasin regions regarding their Pumping Reduction Plans.

10. Report on Technical Meetings with SWRCB Staff, Petersen

Scott Petersen reported that the technical meeting between Subbasin representatives and SWRCB staff occurred on December 11, 2024. SWRCB staff's primary concerns were regarding water quality and the well mitigation plans. SWRCB staff want the plans to address mitigation for domestic water supply wells with water quality impacts. Additional SWRCB staff concerns were regarding tribal outreach and interaction/coordination with the Irrigated Lands water quality monitoring program. An additional meeting with SWRCB staff will be scheduled. At this time, there is no formal update regarding the schedule for the SWRCB probationary hearing for the Delta-Mendota Subbasin GSP.

II. Committee to Discuss Recital Clarification in the Amended and Restated Cost Share Agreement for the Delta-Mendota Subbasin, Bursey/Petersen

Kaitlin Bursey/BMJ explained that in December 2024, Madera County requested a revision to the Amended and Restated Cost Share Agreement to state the Parties' desire to amend, restate and replace the prior Cost Sharing Agreement with the Amended and Restated Cost Share Agreement. As this is a clarifying change and not a substantive amendment, formal action is not required, but the respective member agencies could readopt it if they were so inclined. These revisions altered the formatting of the Amended and Restated Cost Share Agreement's signature block pages and will require the respective member agencies to re-sign.

12. Committee to Discuss Request for Proposals for Program Management Support Services, Petersen

Scott Petersen reported that he has obtained several example Requests for Proposals (RFPs). He hopes that a draft RFP for Program Management Services will be circulated for review by the Subbasin GSAs by January 13, 2025. The plan is to release the RFP by the end of January, and to retain a firm or firms by the start of the next fiscal year (i.e., March 2025). The RFP will be issued to the existing pool of Subbasin consultants as well as other recommended firms. Consultants will be able to submit proposals for any, or all, of the three Committee/GSA groups (i.e., Central, Northern, and Coordinated).

13. Committee to Discuss GSP Implementation, Dumas

- a. Status of WY2024 Annual Report
- b. Update on Modifications of SGMA Round I Grant Funding Program
- c. Update on ISW Monitoring Well Construction Contracting, Petersen
- a. Natalie Cochran/W&C thanked the Northern Delta-Mendota GSAs for submitting their annual water use data for inclusion in the Subbasin WY2024 Annual Report. The water quality and water level monitoring data were also received and posted to the Subbasin Data Management System (DMS). Water surface elevation maps have been prepared using the water level data and circulated for review. The maps will be provided to Ken Schmidt & Associates for preparation of contours.

An estimate of the change in groundwater storage within the Subbasin is being prepared and the draft Annual Report will be available for review in March.

b. Natalie Cochran reported that Amendment No. 2 to the SGMA Round 1 grant is currently being processed by DWR and should be received shortly.

c. Scott Petersen reported that construction of the Interconnected Surface Water (ISW) monitoring wells has been delayed by the contractor procurement processes and ownership responsibilities. Responsibility for contractor procurement is being transferred to the governing jurisdiction of the area in which the proposed ISW well is located. Obtaining the required easements is also complicated. The ISW well construction schedule may be delayed for a few months, while recognizing the completion date of April 2026 for SGMA Round 1 grant reimbursement is unchanged.

14. Committee to Discuss Potential Additional Funding Opportunities, Petersen

No written summary was provided. Scott Petersen noted the availability of some grant opportunities pertaining to environmental justice.

15. Next Steps
